

Court Reconfirms Markman Hearing Date for '672 Patent Infringement Case

Feb. 13, 2006 Markman: Microsoft on Same Schedule

AUSTIN, TX, Oct 04, 2005 (MARKET WIRE via COMTEX News Network) -- Forgent[™] Networks (NASDAQ: FORG) along with its wholly owned subsidiary, Compression Labs, Inc. ("CLI"), today announced that, at a case management proceeding on October 3, 2005, in CLI's patent infringement cases against approximately 40 companies involving United States Patent No. 4,698,672 (the '672 Patent) in the United States District Court for the Northern District of California, Judge Jeremy D. Fogel reconfirmed a Markman hearing on claim construction for February 13, 2006. The Court also placed Microsoft Corporation (NASDAQ: MSFT) on the claims construction schedule.

Following the filing of the litigation, five companies that were defendants have entered into license agreements.
